PERSONAL DATA PROTECTION NOTICE

We have been appointed as Authorised Visa Agent (“**AVA**”) on behalf of the High Commission of the Republic of Singapore in Kuala Lumpur (“**High Commission**”) for purposes of providing Visa Application services. You hereby consent to the AVA collecting and transmitting your personal data to the High Commission and/or its related offices in Singapore for purposes of processing your Visa Application as stated below.

1. Types of Personal Data Processed

During the course of any dealing or transaction with you, the AVA may process personal data which includes but is not limited to personal particulars including name, race, religion, date of birth, age, gender, address, contact details, nationality, passport numbers, financial information, employer information and other relevant documents for purposes of processing your Visa Application.

2. Purpose of Personal Data Processing

The AVA processes personal data for, among others:

- (a) to verify information relating to personal particulars;
- (b) to transmit the same to the High Commission and/or its related offices in Singapore; and/or
- (c) other purposes as consented by you in writing.

3. Failure to Provide Personal Data

The provision of personal data to the AVA is necessary and failure to provide personal data may affect the AVA’s ability to fulfil the purposes under paragraph 2.

4. Disclosure of Personal Data

Aside from transmitting personal data to the High Commission and/or its related offices in Singapore, the AVA shall only disclose personal data for the purposes mentioned in paragraph 2 to the following parties:

- (a) regulatory and governmental agencies as permitted or required by law or authorised by any order of court or to meet obligations to regulatory and governmental agencies; and
- (b) other parties authorised by you in writing.

5. Security of Personal Data
